



What a year 2020 turned out to be! A year ago we were just beginning to hear about the spread of coronavirus, and then abruptly on March 13th we were forced to close our congregate dining program indefinitely for the safety of our staff, volunteers, and clients. It has been a wild ride since then, but through it all we have adapted, adjusted, and remained true to our mission. When we closed our congregate program, diners were transitioned to meal deliveries instead. When containers, PPE, and groceries became unavailable and expensive, Chef Ron scoured the globe for replacements. When social distancing became a necessity we adapted to curbside meal pickups for drivers and cooler deliveries for clients. When we became worried that our clients were even more isolated because of the pandemic we developed the "Friendly Caller" program where volunteers call our clients to check-in and provide resources.

Throughout all of the adaptations and adjustments our network of supporters rallied to carry us through the challenges. Local businesses donated insulated bags and coolers, community members donated hand-sewn masks for our volunteers and clients, and our volunteers kept showing up to stuff bags and deliver meals. Neighbors supported neighbors to ensure that we could continue supporting those most affected by the pandemic. Thanks to your support we are beginning 2021 even stronger than we began 2020. We served 44,261 meals in 2020, and we are primed to increase the number of meals served by 10,000 in 2021. Because of your generosity we are able to provide meals for anyone in need, regardless of their age or income.
